School Bells are Ringing!



It's that time again. On April 2nd, I will begin the last regular course of my doctoral work at Lancaster Theological Seminary, before beginning my writing year. I was asked to write a brief summary of my project to date this month and thought it would be a good way to share with all of you

how the work is going. Before you read the report (below), let me tell you why this work is important. I believe God has given us all gifts to share with the broader community. I believe that our life experiences make us all experts in our own right. Jesus' ministry is all about meeting people where they are and giving them the opportunity to speak into what they need and want. This is why I believe that no group should make decisions or create programs on behalf of other groups without including representatives of those other groups, especially when members of those groups will be so greatly impacted during every part of the process. People who have been unhoused are the experts on how best to serve and create programs that will be effective for unhoused individuals. It is for this reason that I have created a curriculum that equips unhoused individuals to serve on the boards of non-profits that work with unhoused people, and to equip boards to receive unhoused members onto their boards. I am more than pleased and excited about how this work has taken shape, and the great things that the group has been doing. This work has been life changing and inspiring!

Report on the Lived Experience Group and the Homeless Advocacy Board: March 2024

Lived Experience Group: The Lived Experience Group completed its second mock board meeting on February 27, 2024. This was the final meeting for this group. Eight people completed the program which was comprised of eight regular sessions and two mock board meetings.

Six of these individuals are in various stages of working toward board or committee membership with the following groups: Office for the Coalition (O4C), Community Engagement Team of the O4C, Tempo Clubhouse (through CSG), ECHOS, Columbia Dream Center, PA Furniture Mission, and Meals on Wheels. Additional contacts are being made with PRIDE Lancaster. Two of the eight individuals are taking a break before beginning this step.

I have met with each of the boards to explain the program and outline expectations. Boards have voted to accept a person to their board and have chosen a mentor who will meet with me and the participant prior to attending meetings. After three board meetings, the mentor and the participant and I will meet for an evaluation meeting before official program completion.

There are enough funds left in the program budget provided by the O4C to ensure that all participants have transportation to any board meetings or events for the first year of board membership.

Jen Koppel from Community Solutions did two Bridges Out of Poverty trainings at the Moravian Center this month with board members of all participating organizations invited/encouraged to attend. The hope and expectation was that at least one member from each participating board would attend a training. Twelve individuals attended the two trainings.

The Lived Experience Group has decided that in addition to serving on other boards, they wanted to create their own board to advocate for individuals experiencing homelessness. They have chosen the name Homeless Advocacy Board.

decided on the name Homeless Advocacy Board. They officially began meeting on February 13th. They also have designed and adopted a logo. Currently meeting bi-weekly with eight official members and six regular attendees. Meetings are held at the Moravian Center of Lancaster.

The group met with Tim Dzurilla, expert on nonprofit formation in February. His focus was on visioning and strategies for next steps. He gave the group a template for creating a mission and vision statement.

Goals of the group include being available to other groups for consultations, educating the community on the realities of homelessness, and reducing the stigmas associated with it.

The group met with SOWE representatives to give their input on how to structure a locker program in March.

They are currently working on designing a 3x5 card with the most necessary and userfriendly resources for unhoused persons. The goal is for local businesses/organizations to put them on

their counter and/or for staff to have them readily available to persons who come.

The group has been working on video impact statements to submit to the National Homeless Law Center for the Johnson v. Grants Pass Supreme Court case in April.


We are continuing to work on Mission Statement, Vision Statement, and by-laws, as well as seeking a parent organization if and when the group starts seeking out grants or donations. I will initially continue to facilitate group meetings, with the intent of slowly backing off into a consultant/advisor role as seems appropriate.


